- Beth Birmingham thanked the Board of Trustees for accepting applications for the open trustee seat. She also thanked all the applicants including her husband for submitting their interest in serving on the Board.
- Don Soenen listed the record of public service and experience for Gail Grieger. He advised he has known Ms. Grieger for seven years and she always works above and beyond expectations.
- Mr. Harris advised he thought it was awesome that nine individuals expressed interest in the trustee position. He indicated he hopes the eight individuals not chosen will remain encouraged to participate. He also requested that the candidates be honest about their party affiliation.
- Alex Wasso expressed an open election should take place. He hopes the
